## MATCHING CONTRIBUTIONS PROGRAM

EQT Foundation (the Foundation) will match, in cash, on a dollar-for-dollar basis, certain contributions to certain Internal Revenue Code (IRC) Section 501(c)(3) tax-exempt organizations as described below. All employees and directors of EQT Corporation and its subsidiaries are eligible.

Due to the administrative costs of processing contributions, a contribution to an organization must be at least \$100.

### **Application Process—To apply for an EQT Matching Contribution, you must complete the EQT Matching Contributions Application.**

#### **Eligible Contributions**

Contributions matched by the Foundation are subject to the additional following conditions:

- All matching gifts by the Foundation are paid in cash. Nonetheless, employees and directors may contribute cash or publicly-traded securities to Eligible Organizations. When securities are contributed, the Foundation will match the cash equivalent of the average of the high and low prices as of the date of the contribution.
- An EQT Foundation match may not be used to satisfy a personal pledge, contract, or other obligation. You may not, for example, pledge \$200 to an organization, contribute \$100 and use the Foundation match to satisfy the remaining balance owed. Additional prohibited examples include, but are not limited to, the use of a Foundation match to satisfy (i) a winning charity auction bid or (ii) the donation attendant to the purchase of season tickets (athletic or otherwise).
- An EQT Foundation match may not be used to pay for goods or services. Where an employee or director receives a benefit from a contribution, an Eligible Organization may request a match only on the amount by which the contribution exceeds the fair value of the benefit delivered to the employee or director.
- The match will only occur with respect to amounts directly contributed by the employee or director. The purpose of the program is to encourage employees and directors to individually support charitable organizations in the community and NOT to match gifts that are made by others. For example, collecting funds from non-EQT employees that are then donated to a charitable organization by an EQT employee or director would not be eligible for a match. Only funds donated from the employee or director personally qualify.
- Contributions made from donor-advised funds and private foundations are only eligible if the employee or director is the sole contributor to the fund and can certify such by signature on the matching contributions application.

#### **Eligible Organizations**

The organizations eligible to receive matching contributions are as follows:

- The organization must be recognized by the Internal Revenue Service (IRS) under IRC Section 501(c)(3) as a tax-exempt organization to which charitable contributions are deductible for federal income tax purposes. **The IRS status letter must be included with the certification provided to EQT Foundation.** In addition:
  - Institutions of higher learning must be accredited by a nationally recognized regional or professional association and provide a four-year curriculum or graduate level of study. They do not have to be your alma mater.
  - State or regional associations of four-year or graduate degree granting colleges are eligible provided the association transmits all donated funds directly to the member colleges.
  - Organizations organized and operated exclusively for religious purposes (i.e. churches, synagogues, mosques, etc.) are not eligible.
  - The organization must be classified as a “public charity” for federal income tax purposes under IRC Section 509. “Type III non-functionally integrated supporting organizations” under IRC Section 509 are not eligible.
- The organization must be located within the United States. It does not have to be located in EQT Corporation’s service area or other areas of operations.
- Contributions made to donor-advised funds and private foundations are not eligible. Employees and directors are instead encouraged to contribute directly to an Eligible Organization of choice.
- The appropriate financial officer of any applying organization must certify its eligibility under this program.
