## The Program

## Eligibility

All full-time FirstEnergy employees with at least six months of continuous service may participate in the Matching Gifts Program.

Charitable contributions raised by FirstEnergy employees on behalf of Employee Business Resource Groups (EBRG) also are eligible for the Matching Gift Program. EBRG executive sponsor approval is required.

#### Gift Amounts

The FirstEnergy Foundation will match gifts of \$25 (minimum) to \$5,000 (maximum) per employee each year. The FirstEnergy Foundation will also match gifts of \$100 (minimum) to \$10,000 (maximum) for each EBRG per calendar year.

The FirstEnergy Foundation will only match monetary gifts to 501(c)(3) nonprofit organizations. Acceptable monetary gifts should be in the form of cash, check, credit card or distributed from a Donor Advised Fund of a 501(c)(3) community foundation. (The FirstEnergy Foundation does not accept any form of payment).

Employee gifts are eligible for a matching charitable contribution at 100%. EBRGs are eligible for a matching charitable contribution at 150%.

## Matching Gifts Recipients

#### Eligible

Organizations **eligible** to receive FirstEnergy Matching Gifts from employees and EBRGs must:

- Meet the nonprofit, tax-exempt requirements of the Internal Revenue Service as 501(c)(3) and not be further classified as 509(a)(3)
- Be located in FirstEnergy's six-state service territory or where we conduct business. This includes contributions to a national organization which must be designated to a local chapter within FirstEnergy stated boundaries, as well.

Contributions may be designated to a specific activity or program, except where there is a direct personal benefit, such as event tickets or membership dues.

If the employee is a graduate, gifts to a post-secondary educational institution are matched regardless of its location.

#### Ineligible

Organizations **ineligibl**e to receive FirstEnergy Matching Gifts from employees or EBRGs are found in the Matching Gift Program Guidelines.

Ineligible contributions include gifts for:

- Tuition, books, student fee payments
- Salaries, stipends, or scholarships
- · Event tickets for dinners, performances, or golf outings
- Religious, political or legislative activities
- Alumni dues
- Athletic programs
- Any direct personal benefit
- Combined/pooled donations or resources (except approved EBRG fundraisers)

## How to Apply

## **Employees and EBRGs**

Complete Part 1 of the application form

#### **Employees**

Complete the Individual-Employee Gift section of the application and mail along with your gift or receipt to the organization.

#### **EBRGs**

Track funds from eligible employees and verify that eligible employees made the donations. Complete the FirstEnergy EBRG Gift section of the application and mail, along with the charitable contribution, to the organization.


