The Brink's Company Matching Gifts Program

Description of Program

The Brink's Company Matching Gifts Program was established to encourage employee contributions to educational/cultural institutions, social service community organizations, hospitals, and environmental organizations, and is an important part of the Company's overall contributions program. The Company will match employee gifts of \$25 or more, up to a maximum \$10,000 in any calendar year.

Eligible Individuals

Full-time salaried employees of The Brink's Company and its U.S. subsidiaries are eligible to participate in the Program.

Eligible Educational Institutions and Alumni Associations

Accredited graduate or professional schools (including separate schools within a university), four-year colleges, two-year junior or community colleges, private elementary or secondary schools (operated and controlled by an independent board of trustees) located in the United States, whether supported privately or by taxation. Accreditation must be determined by an appropriate nationally recognized regional or professional association.

Alumni associations or funds established to receive contributions for educational purposes solely in support of the school with which they are associated are also eligible. In addition, state or regional associations of private colleges and national associations or funds soliciting support for education are eligible.

Eligible Cultural Institutions

Public and other tax-exempt cultural organizations such as museums, libraries, art galleries, orchestras, opera, dance, theater, historical associations, public radio and television stations, and botanical and zoological societies located in the United States are eligible.

Other Eligible Institutions

All non-profit hospitals are eligible. Social service community organizations (such as Boys' and Girls' Clubs) and environmental organizations (such as the Nature Conservancy) are eligible. Community Funds other than United Way are eligible.

Ineligible for Matching Gifts

Gifts ineligible for matching include: bequests, tuition, housing or travel subsidization, or similar items; subscription fees for publications, insurance payments, dues, payments for clubs or fraternities; support of athletic programs (such as construction of athletic stadium or athletic scholarships); gifts directly to religious institutions or gifts intended to fulfill pledges, tithes or other religious-related financial commitments; gifts made with funds provided to donor for donation purposes by other persons; gifts to political organizations. Also ineligible are any gifts to donees that the IRS does not recognize as qualified for tax deductible contributions.

Form of Contribution

Contributions must be the personal gift of an eligible individual in the form of check, money order or credit card. A pledge or other form of promise to make a gift in the future does qualify for matching.

How the Program Operates

- The employee donor completes Part 1 of this form and sends the entire form, with the gift, to the eligible institution.
- The eligible institution's finance officer fills out this form and mails it with required substantiation to the Matching Gifts Officer in each Operating Group's Human Resources Department.
- The Human Resources Department verifies eligibility of the gift and mails the matching payment to the institution.
- The Company will notify the employee/donor when the matching gift has been transmitted to the eligible institution.

Conditions

Any questions regarding matching gifts should be addressed to the Human Resources Department.

Any matters relating to the interpretation and scope of this program or the final determination of a question relating to the eligibility of an educational or other institution to receive a matching gift will be decided by the Company and its decision will be final. The Program may be suspended, terminated, or amended at any time.
